Assembly member Connolly was elected to represent the 12th Assembly District in 2022, and is running for re-election. 
SRDC Club News

Monica is now in Washington, DC beginning this training program which will end after the November 5th General Election. This is truly building the bench, and I will let her know we all clapped for her, and our club got to contribute to her.

Sandy thanked **Diane Lange** for sponsoring tonight's meeting. She is unable to attend, but we are so very thankful for all of our meeting sponsors. A special thank you to **Leslie Graves** for her creative and thoughtful idea of having meeting sponsors. It has assisted our club greatly to be able to do this. If anyone is interested in being a meeting sponsor, you will get two free dinners, and you name is shown in our newsletter as well as being announced at our club meetings (see page 11).

Sandy acknowledged the attendance at our meeting of Presidents from two of our 10 chartered Democratic Clubs, **Beth Hadley of Sonoma Valley Democrats**, and **Eric Vazquez of the Wine Country Young Democrats**.

Sandy also acknowledged that in February, our club sponsored three Vice Presidential tables at the Sonoma County Democratic Party's annual Crab Feed. It was a sold out event, and asked all those that attended the Crab Feed to stand. Thank you for your continued support of the Democrats in Sonoma County.

Nanci Hoban acknowledged our club's Crate Crazies Team, Susan Saludes, Linda Graves, Ginger Kelly, Bonnie Petty, Deb Olcott and herself for working tirelessly to create over 27 crates for the SCDP Silent Auction Crab



Feed. Due to this incredible work along with the Democratic Club of Southern Sonoma County for their baskets, the Silent Auction raised \$6,600. Three of the crates did not sell and were available for auction at our meeting this evening. It is noted one sold. The other two will be held for the future.

Nanci also reported on our postcard writing group. She thanked **Linda Graves** for managing the postcard writing for several CA races. We will be doing another campaign next month. Please email Nanci at nfhoban@gmail.com if you are interested in joining this group.

Sandy noted that Bonnie Petty was unable to be here this evening. She will be talking about a special program that **CARA** will be hosting in May (see page 10). Our club is a member of the **California Alliance for Retired Americans** (CARA) which means all members of our club belong to CARA. Bonnie will be here at the April meeting to talk about CARA.



Pat Sabo, Chair of the Sonoma County Democratic Party (SCDP) noted that since we last met, we had an election. Now we know what we are facing. The County Party did set goals for the primary election. Our results turned out pretty decent. Of the

6 endorsed candidates, 5 were elected. On measures and propositions, two did not make it. Most were school bonds which required 2/3's of the vote to pass. We had 5,000 slate cards. Many were given to our endorsed candidates and the remaining ones were walked out of our office to homes in Sonoma County. We set a goal of 1,600 slate cards to be dropped at homes from the office and ended up dropping 3,760 total slate cards. Our goal for postcards was 8,500, and we sent out 19,030 postcards! Postcards included campaigns in other states. This is all voluntary. Many individuals worked for candidate campaigns as well. We are very pleased with what we did.

Pat further noted that the SCDP Crab Feed is attracting more and more "BIG NAMES" throughout the state. She stated we are doing the right things, and none of this happens without the support of each and every one of you. We have room for ALL. Watch for news about our BBQ in August. SCDP is building every year.

Pat stated that tomorrow is Sandy Reynolds birthday so we had a rousing chorus of Happy Birthday Sandy!

Finally, as you know, our current Assemblymember Jim Wood (District 2) announced by surprise that he would not seek re-election. This became an open seat with about 2-1/2 months to put together a campaign and win a hotly contested race. We are in an incredibly BLUE area, but when you have 7 or 8 Democrats and 1 Republican, it became a tight race for the Dems. At this point, it looks like our own Chris Rogers will be our next Assemblymember from District 2 after the November 5th General Election. We will miss him on the Santa Rosa City Council.

Chris Rogers thanked Pat for the introduction and stated we knew if we could get out the vote in Santa Rosa and Sonoma County, we could squeak out a win. That will be about 1400 votes. I would not be here looking at November without all of the volunteers who



worked for me. When you pick a candidate that you believe in, do the volunteer work for them.



Nanci Hoban introduced our guest speaker, Sonoma County Supervisor, District 1, Susan Gorin. Supervisor Gorin thanked all of us stating we are an affinity group. We've shared experiences together and learned from those experiences. She noted she has

been helped by our Democratic clubs, and if she had not had us, I would not be here standing before you today. We are strong, we are powerful, and when we are united, we are even more effective. This is her last year of her third and final term. She recognized all of the school board trustees who are struggling with many issues. She noted that Chris Rogers was the person on the Santa Rosa City Council she always

called on when she needed help. I predicted you were going to win, and we will miss you in Santa Rosa. Gorin gave a heads up to Santa Rosa City Councilmember Mark Stapp stating. "You can do it Mark."

Supervisor Gorin took office as Chair of the Board after her third election and walked headlong into COVID. Many challenges from many perspectives including how do we survive in isolation. Silver lining is that Zoom allowed us (and other platforms) to meet with folks all over the district. We are very dependent on technology, and we do not have full access to that yet.

Some of the major themes included a living wage ordinance and noted we have just approved amendments on that this past Tuesday. Have modified the Project Labor Agreement, and noted that tree preservation finally came forward. Still working on trying to figure out the Sonoma Development Center, and Hanna Center. Gorin noted serious concerns about evacuation plans for Sonoma Valley especially with the homeless services on the Los Gullicos campus. This campus is so far away from needed services. She is turning in a budget request for an evacuation analysis of the Los Gullicos campus noting Oakmont has one.

She very much wants to work on the Springs Community Plaza which she started a couple of years ago in partnership with an investor/developer.

Gorin noted she made it clear when she was elected for her third term that she would be retiring and asked her staff who should run for her seat. To a person, they said Rebecca Hermosillo. They met, Rebecca checked with her family, and her Congressman, and has hit the ground running to move into this new position in January.

Congratulations Rebecca!

Nanci Hoban introduced our next guest speaker, Supervisorelect, District 1, Rebecca Hermosillo. Supervisor-elect Hermosillo stated she is very

excited to be here. Her life has always been about helping people including what she has done the last 11-1/2 years with Congressman Thompson's office.

to be asked. She wants other BIPOC people to run and is looking forward to filling seats on committees and commissions with young people. She thanked Logan Warren who helped to support her by putting up her signs, and Devon, our intern at the Congressman's office for that help. She feels very fortunate that Supervisor Gorin is leaving the district in great hands. Next year there will be a lot of priorities and looks forward to working on the issues and being focused on the constituents in the district.

She ended by thanking us for making history!

Q: What is happening with incorporation of the Springs into the city of Sonoma? A Gorin: We are in discussions regarding the annexation. There was an attempt about 15 years ago indicating the residents of the city of Sonoma did not want to do this. It took a lot of city activists in electing the right people on the City Council and the Board of Supervisors to bring this back. Hope Springs Eternal. A: Hermosillo: At this time she doesn't know the timeline and needs more community input about why we would look at annexing. A: Gorin: Why this might be important is that a coalition is debating about how to fund homeless services and providers. If this area were actually in the city, we wouldn't be having this conversation. The next step is the city of Sonoma to explore the steps and have community conversations about annexation.

Q: What types of Brown Act training do the supervisors have? A. Gorin: Gorin stated we take this very seriously, and have trainings frequently throughout the year. Rebecca will meet about learning the Brown Act. It is very serious, and we need to abide by that. We have been having a number of closed sessions on DEMA. In closed sessions, we can only talk about very specific things, and are required to abide by that. We are now trying to reconcile that and get the records in place. I believe the full report is now on the Auditor/Controller/Tax Collector website. A. Hermosillo: As Supervisorelect, I am living in the spirit of the law, and will meet about learning the Brown Act.

Q: What is the latest on the Sonoma Development Center (SDC). A. Gorin: We are on a broad-based coalition to preserve the SDC. It can be used for many things. Currently, there are no utilities; no

electricity, no water, no sewage. The state has selected a developer who has proposed 1900 units. We are looking at 620 units with a max of 720. I am unsure if this project will move forward in my term or Rebecca's. It is also caught up in a state bill SB1330.

The supervisors are trying to figure out how we review that. This will be really challenging and in litigation with the neighbors.

Q: For Rebecca Hermosillo: What county boards and ad hocs do you want to serve on? A: I have a lot of appointments to make. I need to do more leg work to try to find the best spot for me. The Chair of the Board of Supervisors makes the appointments.

Q: Will the Oakwood Lands protection come with putting a moratorium on vineyards? A. Gorin: For agriculture, it is mostly about maintain the vineyards we now have. Losing the hillsides through vineyard conversions is a concern. Protections are for all trees and there are hefty changes to cut down some of the trees. This is coming back to the Board in April. We are in a moratorium in tree cutting. A. Hermosillo: Having been raised in the wine industry for years, some vineyards are being pulled out for oversaturation. She noted that only 6% of county land is planted in vineyards. The industry is going through a lot of consolidating.

Q: For Rebecca Hermosillo—what are you most excited about working on? A: Hiring staff. I have such a good team at the Congressman's office. I am excited about starting fresh and how to train to work with our constituents. I want to be a resource to my staff. I am also looking forward to working with state and federal elected which I currently do.





Executive Board & Treasurer's Reports

EXECUTIVE BOARD REPORT:

David Cahill, VP of Membership, gave an update on 2024 memberships at 92 paid members. We remind board members and those who have not yet renewed to do so. We invite new members as well.

Nanci Hoban reported that Assemblymember Damon Connolly will be our guest speaker at our **April 24th meeting** in **honor of Earth Day.** She noted she is working on 2024 programs.
